Gentlepersons:

In consideration of your continued presentation through September 30, 1984 of the play "ARE YOU NOW OR HAVE YOU EVER BEEN" written by Eric Bentley and your negotiating with Mr. Bentley and us for our acquisition of certain rights therein pursuant to the agreement attached hereto and marked Exhibit A, and for other good and valuable consideration, receipt of which we acknowledge, we hereby agree to:

1. pay you concurrently with payment to Mr. Bentley, amounts equal to two-thirds (2/3) of all sums payable to Mr. Bentley pursuant to Exhibit A, it being agreed that payments to you hereunder shall not decrease payments to Mr. Bentley pursuant to said Exhibit A, and

2. accord credit on a separate card in the main titles of any photoplay produced pursuant to said Exhibit A, as follows:
